My dear Gowri Priya DEVARA

*"Welcome" candidate "and let's hope; Care & Share, you and I, to deserve and obtain the degree in Pharmacy for Gowri Priya.*

*But also, and this is my (no longer secret) purpose, to give you your path, your freedom".*

These are the words I communicated to Care & Share, the institution to which I recently turned to find an Indian who lives in a state of anxious desire to obtain things that are apparently not achievable without help modifying the contingent.

This is the meaning I found in your letter and it touched me a lot: *With a tear in my heart and a poem in my eye.*

Now, overcome the emotions of an unexpected meeting, no more thanks and fibrillation, tomorrow is how we design it today.

So, let's meet again, let's start again where we started already 19 years ago, we've known each other for so long that we have forgotten a few things ....

So, let's start (childbirth: separation of the unborn child from the mother) for this journey without imagining, but touching what we will encounter, we will experience and therefore we will conquer the freedom that passes through the studies in the pharmacy and which are one cultural growth tool.

My parents called me Luigi and I was born 75 years ago in Cinisello Balsamo and I lived between Cinisello Balsamo, Milan and Busto Arsizio.

I traveled around the world for a while and among the destinations there was also India where I stayed for five months and accumulated many unpaid (moral) debts.

I have never loved studying on books but I have always favored the culture accumulated from practical experience.

Professionally I have tried different activities, I started as a delivery boy and finished as an administrative director.


I had a wife who gave me a child but then we went our separate ways.


Now I live with a cat who has her instinct to scratch and bite intact. I never understood if they are symptoms of affection or aggression. In short, a miniature (Bengal) tiger.

I have had several health problems, I have the aftereffects of a stroke that happened to me in 2010 and occluded a blood vessel on the left that inhibited the functionality of the right.

Here some clarifications are needed: the functionality of the right leg will worsen over time (I immediately lost my balance and vrkasana became impossible for me) while, inexplicably, the right hand has no damage. But when it comes to writing, it doesn't want to know, the brain sends out strange commands. It happens only in writing but not, for example, in completing precision work. Sometimes I need to take notes that I regularly write by hand but after a few hours, of the same, I do not decipher its meaning.
