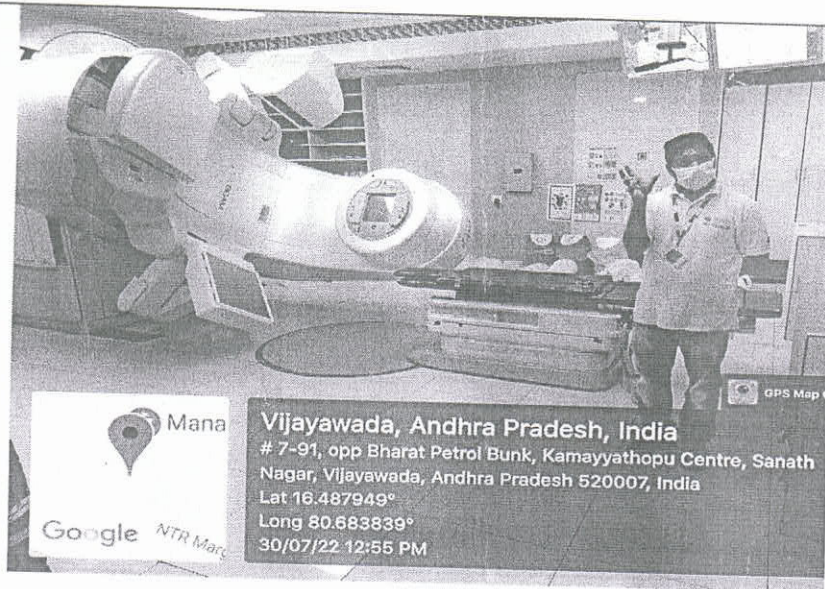
We were guided by a tour by host who explained in details about the equipments that are used in cancer treatment

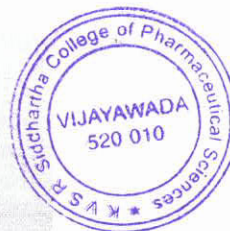
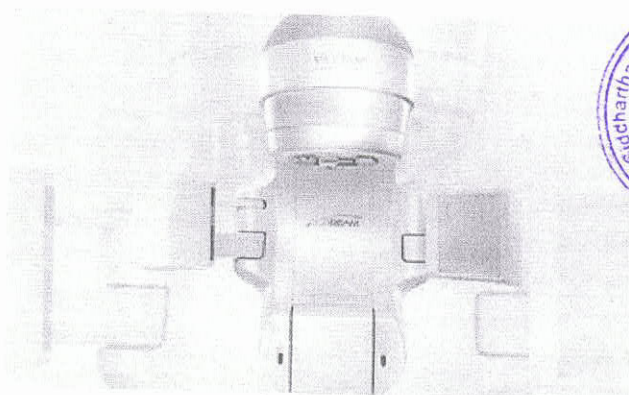
### How to deliver beam to the target precisely in moving organs

#### (4D CT and Real-time Position Management Systems )

Breathing causes some organs keep going move during a treatment (ex. Lung, Upper abdominal Sites). In turn, we trace patient's respiration cycles and make the treatment plan by reflecting that data in some cases. 4D-CT and Real-time Position Management Systems (RPM) allows clinicians to correlate tumor position in relation to the patient's respiratory cycle.

4D-CT provides clean images for planning so that clinicians can visualize the target more clearly with fewer of the image artifacts associated with respiratory motion.

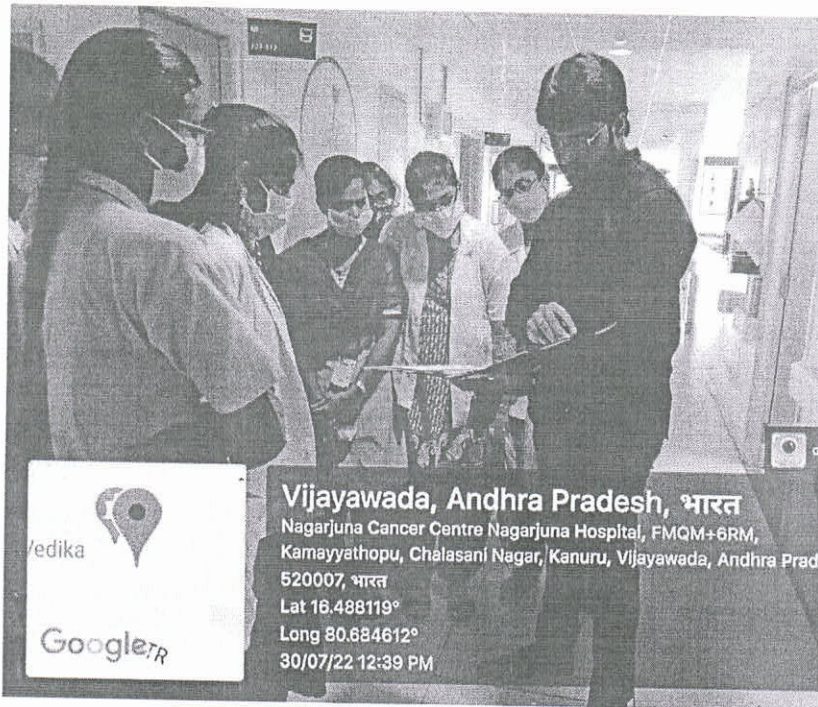
This system also helps to minimize dose to healthy tissue during the radiation therapy. In addition, we have GE high speed 4-D CT scanner and Varian RPM systems that are widely used in the world.

 the pharmacy primarily prepares chemotherapy for each patient. If it is necessary to dilute/mix the medicine at the department, then this should occur in a designated room with a LAF bench (laminar airflow bench). Many chemotherapy drugs

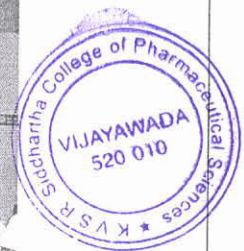
